ORDER
Granting Patent Owner's Motion for *Pro Hac Vice*Admission of Joel B. Rothman
37 C.F.R. § 42.10

On January 10, 2022, Patent Owner filed a Motion for *Pro Hac Vice* Admission of Joel B. Rothman. Paper 4. The Motion is supported by a Declaration of Mr. Rothman. Ex. 2001. Patent Owner indicates that Petitioner does not oppose the Motion. Paper 4, 3.

It is, therefore,

ORDERED that Patent Owner's Motion for *Pro Hac Vice* Admission of Joel B. Rothman is granted, and Mr. Rothman is authorized to act only as back-up counsel;

FURTHER ORDERED that Patent Owner is to continue to have a registered practitioner represent it as lead counsel;

FURTHER ORDERED that Patent Owner must file a Power of Attorney for Mr. Rothman;

FURTHER ORDERED that Mr. Rothman is to comply with the Consolidated Trial Practice Guide<sup>1</sup> (84 Fed. Reg. 64,280 (Nov. 21, 2019)), and the Board's Rules of Practice for Trials as set forth in Part 42 of Title 37, Code of Federal Regulations; and

FURTHER ORDERED that Mr. Rothman is to be subject to the Office's disciplinary jurisdiction under 37 C.F.R. § 11.19(a), and the USPTO Rules of Professional Conduct set forth in 37 C.F.R. §§ 11.101 *et seq*.
